Treasurer Report

Hello everyone.

On July 1, 2021, the opening bank balance was \$33,244.23. After deposits of \$16,566.53 and expenses of

\$13,990.07 the August 31, 2021, ending book balance was \$35,820.69. After deducting \$10,000.00 withheld for the next RSC, the Prudent Reserve of \$11,000.00, a Women in Service Donation of \$75.00, the GSR Assembly Reserve of \$6,000.00, and the Florida Service Symposium Reserve of \$6,000.00 the available balance was \$745.69.

As of RSC held on September 19, 2021, we received \$11,760.44 in income and had \$12,506.13 in expenses; which includes a donation of \$1,000.00 to the Southeastern Zonal Forum. Additionally, I allocated the monthly reserve of \$1,000.00 for the GSR Assembly & Florida Service Symposium. Therefore, after RSC business the available balance was \$5,572.98, which was sent to NAWS.

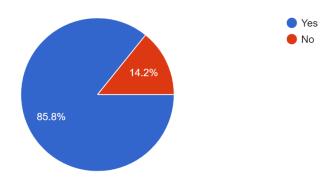
1. Are you now or have you ever been a GSR? 156 responses

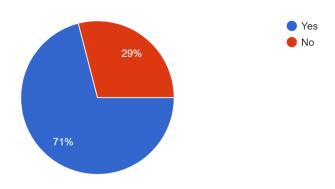

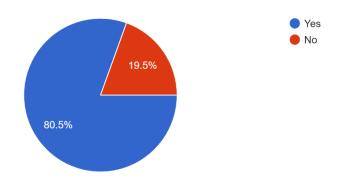

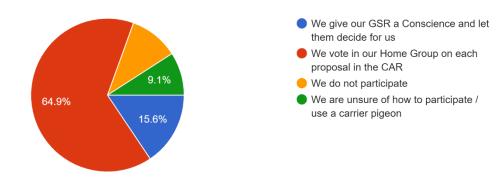


Do you know what the World Service Conference (WSC) is?

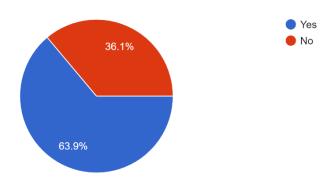


How does your home group participate in the decision-making process at the WSC? 154 responses

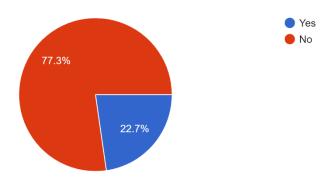


Do you know the purpose of a GSR Assembly?

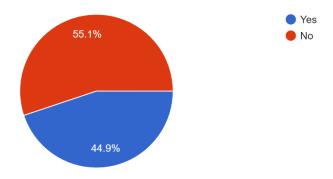

Do you believe that the GSR Assembly is only for members who are involved in Service? 154 responses

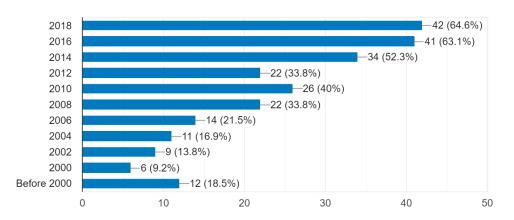


Have you ever attended a GSR Assembly? 156 responses



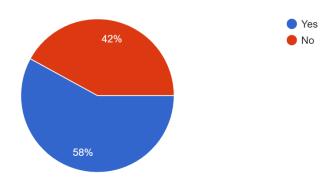
What year(s) did you attend?

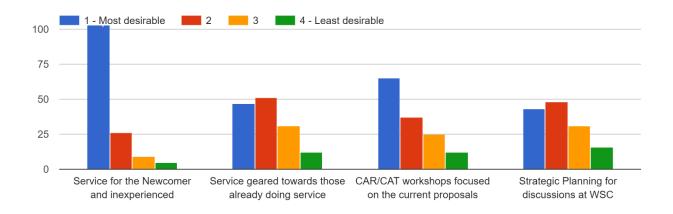

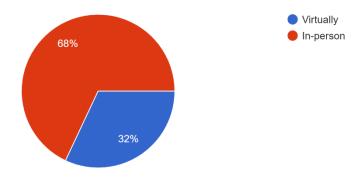

Technology Resource Coordinator Report

IT Report September 2021

With Ezra rolling off after the September RSC, we are looking for someone to step into the role of Technology Alternate Resource Coordinator. RCMs, please bring this back to your areas and inquire with your local tech girl/guy. The description for the TARC role is in the Guide to Florida Regional Service, pg 31, and the TRC is on page 29-31. Anyone considering the role can contact Ezra, Michelle, or HRP for more information. Please also fill out the HRP volunteer form at naflorida.org/hrpform.

Hybrid Regions

We would like to continue to try to make regional weekend accessible to people who cannot be here for financial, health, or other reasons. Our current hotspots have not been able to provide consistently stable internet connection which is detrimental to the zoom participants and super annoying to everyone involved. So far, we've been unable to find a better solution that is also cost effective. We will be purchasing an internet connection from the hotel for every region moving forward. We anticipate this will cost the region approximately \$200 per Regional weekend but will continue to search for a more cost effective solution.

We are asking all RCMs to let your areas know that Regional Weekend will continue to be made available to all NA members and details are posted on the website at https://naflorida.org/rsc/. Per our discussion during Saturday FD, we will be creating a flyer to remind members to join us hybridly.

Website

Michelle and Alex have finished combing through the original website. Ezra and Chris will be setting up the development site which is basically a staging area where the existing website will be copied over to and the new theme will be implemented and checked for issues. While they are working on that, Michelle and Alex will be working on creating documentation (best practices) to be passed along to whomever will be taking care of this

website after we roll off. Our secondary purpose is to make sure that we leave a system that is simple, effective, and easy to maintain.

Sub

Sub is a SMS subscription service that was built by the BMLT team. It is very immature currently as only the Carolina region uses it. I (Ezra) am personally doing development work, which does not fall under my duties as your Technology Resource Coordinator, to make it a sophisticated enough service that I would recommend this body use as a method of communication. I hope to be able to demonstrate and offer that service to the Florida Region in the near future.

BMLT

I (Ezra) have been working with South Florida Region as a resource for them to help get the various areas in Dade county to utilize the Basic Meeting List Toolbox (where we store our meeting info) and get them set up on crouton (a wordpress plugin to display meeting info on a website), bread (a wordpress plugin to create a printed meeting list), and yap (advanced phone with automated meeting lookup). As your Technology Resource Coordinator team, we have already expressed willingness to assist Recovery Coast and Treasure Coast with getting on these systems and we are more than happy to assist any area that is using manually updated meeting information systems in upgrading to the automated and advanced capabilities offered by the BMLT software.

Yap

Yap is the new phoneline which is a dramatic cost savings from our previous system, grasshopper. It also allows for more advanced features such as automated meeting lookups by phone and/or text. We have made much progress since we began this migration project 8 months ago.

- -Areas that were on Yap prior to last RSC: First Coast, Treasure Coast
- -Areas that have moved since last RSC: Big Bend, Chain of Lakes, Coquina Coast, Forest, Heartland, Nature Coast, Palm Coast
- -Areas that are in the process of moving and will be completed in the next couple weeks: Greater Orlando, Recovery Coast, Serenity Coast, Suncoast
- -Areas that are not in the process of moving: Bay Area ASC just approved the migration to yap and I will coordinate a training with their new helpline chair. Daytona has until now not been interested in moving to yap since they prepaid their current system until January I will be bringing this back up soon with their new phoneline chair. River coast seems unwilling to move and I have been struggling to get returned calls from Jason. Space Coast area approved the migration and we are very optimistic that their helpline committee will approve that as well and we can begin the transition process. Tampa Funcoast's helpline chair has been difficult to maintain contact with and the only person that has contacted me to try to make the transition is a helpline member's secretary who is a non-addict. After discussing with multiple people and trying to relay messages through the RD to the helpline chair, I am uncomfortable working with a non-addict on this as I see it as a 7th tradition issue. I am happy to train the helpline chair or any addict on the helpline committee. Uncoast appears unwilling at this time to move but perhaps they may be more willing as they hear of everyone's successes with yap.

We are currently on Yap 3.9.9. A new version - Yap 4.0 is in beta testing and I am spinning up a server to assist the BMLT team in testing it. It would be my guess that the SEZF will be one of the first servers to upgrade. We will be sure to communicate to helpline committees any changes and new features, many of which were sourced from Florida region areas.

As of today, the entire region and its areas are collectively saving an estimated \$345/month in phone bills. Our bill last month was \$42 for both regions together. So that is a net savings of around \$320 for the Florida region and its areas. We do anticipate our bill going up, but our savings will increase dramatically as we shut down Grasshopper and consolidate various area helplines.

On a personal note, I attended several workshops at the Multi-Zonal Service Symposium virtually and was even able to do a demo of our yap setup to people across the country. I have since been asked to present a yap workshop at Multi-Regional Service Learning Days next month but I'm not sure if logistics will allow it. I thought this was a super cool thing to share with everyone as a blessing of being able to serve this body and keeping the Florida Region at the forefront of technology in NA and a leader for other regions.

Today finishes my (Ezra's) commitment I've held for the last 3.5 years. I have learned a lot and I am grateful to this body and specific members who have shown me how to serve. I want to express that this region is in great hands with the incoming Technology Resource Coordinator Michelle. She has my full confidence that she will be a great TRC and I am happy to assist her behind the scenes and be a resource for anything she may need. It has been a pleasure to serve with her. Rest assured, I will continue to attend FD/RSC as I just moved to Greater Orlando and this has become a family for me. I do have the willingness to accept another appropriate position (mostly so yall have to listen to me on Sundays too) if the opportunity arises, and I'm sure I'll find a way to help out until then. Thank you for allowing me the opportunity and trusting me to serve.

Corrections Resource Coordinator Report

Greetings Florida Region,

My name is Colin H and I'm an addict. I am currently serving as the Corrections Coordinator for the Florida Region and the lead for the Corrections Workgroup.

What is the corrections workgroup you say?

The corrections workgroup consists of several related projects that serve to bring the message of NA recovery to the addicts behind the walls in the state of Florida. We also work with and educate the administration at the state level DOC regarding the continued success of NA to improve the lives of those they serve. Please be aware that working with the DOC does not mesh well with the spirit of rotation and does not sync with the spirit of anonymity.

These top level projects are:

Behind the Walls: taking meetings into and building homegroups that exist behind the walls of state and federal correctional institutions. This includes literature delivery to institutions to support this effort.

Inmate Step working guide is alive and well and working steps through the mail with those behind the walls. This group is based out of the Gold Coast area.

The Bridging the Gap program is alive and well and addicts are being scheduled to meet those who are getting released at a meeting. Recently as part of brainstorming during the workgroup, the bridging the gap program is being opened up outside of just those within the corrections workgroup. There are several members in various H&I subcommittees across the region that we have found would be willing to meet members after their release.

Corrections is still struggling. We have gotten several requests for more meetings at institutions from Chaplains, as well as requests from inmates, as well as a large influx of support after the recent FRCNA Behind the Walls presentation. We are currently attempting to coordinate presentations at a handful of institutions in the Florida Region.

The workgroup struggles to get consistent volunteers, please join!

We meet every other Thursday from 8-9p over Zoom.

Goals for the next 2 years

Double my budget for literature for those behind the walls

Get all of the NA literature on the tablets at the institutions

Get Zoom meetings going in at least one institution.

Build a database of Bridging the Gap folks in every area to meet those being released from institutions

Keep the behindthewalls.us website up to date with which meetings are meeting where and when.

Create a virtual phone number and virtual mailbox so that the next corrections coordinator doesn't have to give out their address but can still have a way to get stuff and the contact information can be consistent.

Needs!

Volunteers willing to take meetings into facilities who are comfortable with masks and personal health preparations enough to still bring meetings in.

A secretary to coordinate communication with the facilities and the volunteers and to maintain

the Google drive and the calendar for when we go into facilities, and to chaperone the WG meetings. This would be a couple hours of work per week.

A webservant to maintain the https://behindthewalls.us/ website and talk with the secretary to

keep the list of institutions we are serving up to date. Again, a couple hours of work per week

A Volunteer coordinator: This person would communicate and coordinate with the Inmate Step working group (ISWG) out of Gold Coast, the area H&I chairs to see if they have volunteers willing to take meetings into DOC or Federal institutions in their areas and to maintain and connect with the volunteers we have in the database now to encourage them to attend meetings and track and ensure that they have maintained the state requirements for training. Again, a couple hours a week.

A bridging the gap coordinator - This person would attend the biweekly meetings, and keep in touch with the H&I chairs for each area in the Florida and south Florida regions to find out if they have individuals on their H&I member lists who would be willing to meet a new member that got released into their area and take them to their first meeting and maybe out to eat afterwards.

A ISWG coordinator - This person would attend the biweekly meetings. This person will keep in touch with the Gold Coast ISWG and be able to ensure that Chaplains and Institutions are getting the information about the Step Working Guide (contact the chaplains and make sure they have the flyers). The expectation for this person is that they will be able to provide feedback and some stats and information about how many addicts are being served by the ISWG at the bi-weekly meetings.

Hope Rises program coordinator: This person would attend the biweekly meetings. This person will keep in touch with the Hope Rises program and be able to ensure that Chaplains and Institutions are getting the information about it (contact the chaplains and make sure they have the flyers). They will provide information to the Hope Rises program to get the books to the institutions that need it and relay information about how many books are being sent and to where. This information will be kept in a spreadsheet that will be presented to the Florida Region so we can highlight the program and the addicts it is serving behind the walls.

Literature Chair: This person will maintain the literature spreadsheet that is kept by the Corrections Workgroup and ensure that any literature sent to institutions or given to members taking meetings in is tracked so that we can be accountable back to the Region.

Mailbox chair - get the information from the virtual mailbox and present it at the biweekly meeting and provide it to whomever needs it.

I've attached the flyers to my report that are being sent to all chaplains for posting in the institutions.

RD/AD Report

I want to start out today by thanking this body for allowing me to step up into the RD position. I some big shoes to fill as my predecessors have set the bar high. However they are all very supportive and have answered my calls and supported me in my first months in the position, thank you all. Also lets welcome Ramon who is now your AD and has jumped in with both feet running. We both attended the Multi Zonal conference in San Antonio, Texas virtually and there will be more on that from both myself and Ramon later in the report.

Conference Participants Meetings and next WSC:

The last conference participants meeting was on August 21, 2021, 11 am - 1 pm PST. At this conference participant meeting we voted on in order to decide how the next Conference will be held. Whether an in-person WSC will be possible or not, given the existing and potential travel restrictions, health considerations, and the continuing financial strain on World Services.

The board's recommendation is that due to current travel restrictions and safety concerns, the current 2020-2022 Conference cycle be extended to 2023. In the interim, a short, interim virtual Conference meeting would be held in 2022 to deal with the most immediately essential business. The 2022 meeting of the WSC will then recess and reconvene in 2023.

The next discussion was about what essential business is. Essential Business suggested by the Board:

- 1. NA World Services Budget for one year 2022-2023
- 2. Extend existing FIPT moratorium on inspection clause for one year. (Acting as the trustor, the delegates present at the virtual WSC 2022, are continuing the suspension of Article 5, Section 3 of the FIPT Operational Rules, while we make a decision about the future. This suspension will expire at the close of WSC 2023.)
- 3. Adjustment of terms for WSC trusted servants. (the details of this will be provided)
- 4. The approval draft of the Spiritual Principle a Day book (SPAD)

Upon the conclusion of the Conference Participants Meeting August 21, 2021 there was an e-poll sent to the participants in order to make the final decision and these are the results:

The following motions were decided on via electronic poll. Conference participants had 72 hours to respond to the poll, beginning Thursday 26 August and ending Sunday 29 August. 123 participants took part in the poll.

Motion V1 (from 2020 but revised to be a policy): When the WSC chooses to meet virtually, all World Service Conference participants may participate and vote remotely in the same manner as the current policy for participants who are unable to obtain visas:

"Participants who are unable to attend the WSC due to visa issues may participate remotely. Remote participants have the same rights as if they were at the WSC" 2020 GWSNA

To accommodate the variety of time zones and to ensure an accurate record, decisions of the WSC can be made outside of the WSC meeting by e-poll that is sent to all seated Conference participants.

Maker: World Board Intent: To allow the Conference to choose to make decisions virtually when necessary.

Motion V2: Due to travel restrictions and safety concerns from the global COVID-19 pandemic, the 2020-2022 Conference cycle is extended to 2023. A short, interim, virtual, Conference business meeting shall be held in 2022 to fulfil our obligation to address legally essential business, as described in Motion V3, and to approve the Spiritual Principle a Day book if the WSC chooses to do so. After the essential business is conducted, the 2022 virtual meeting of the WSC shall recess and reconvene in 2023. Dates and deadlines pertaining to the meeting of the Conference in 2023 shall be provided by the World Board, including CAR motion deadlines, and seating application deadlines.

Maker: World Board Intent: To adapt the current Conference schedule due to the global pandemic.

(Acting as the trustor, the delegates present at the virtual WSC 2022, are continuing the suspension of Article 5, Section 3 of the FIPT Operational Rules, while we make a decision about the future. This suspension will expire at the close of WSC 2023.)
- 3. Adjustment of terms for WSC trusted servants. (the details of this will be provided)

FINANCIAL STATUS

We are more than a year now into the pandemic and the most pressing issue is financial. As has been said before this has been a challenging times for World Services, and some of the challenges are still with us. So for the good news for the first time in decades contributions represented 25% of our income during the last fiscal year. That is up 10% since the last fiscal year. World wants to thank everyone who contributed and helped NAWS stay afloat. However now most notably, they are still operating at a deficit, meaning World Services' expenses are still exceeding our income. Literature sales are continuing to be depressed. It is going to take a long time to build back up from the financial crisis of the past year. There is a silver lining in the pandemic as it has given the world us opportunity to finally make a long-needed shift from dependence on literature sales for income to a future where NA is self-supporting through member contributions from service bodies, groups, and NA events. The long term goal is to cover at least 70% of the expenses for services through contributions. We have made progress in this area and are about 40% there but there is more work to be done.

The way this has been accomplished is world have cut costs where they are able. Many of the staff remain furloughed still or have been laid off. The staff that are working have not been traveling to fellowship events r having any in-person Board Meetings. They have not travelled to Fellowship events or Board meetings in more than a year. They are not doing paper mailings of our publications or review drafts. They had to make that change because of the pressures of the pandemic, with so many staff furloughed and working from home, and because of budgetary pressures. In some cases, they are unable to reduce expenses. For instance, they are contractually obligated to the terms of our equipment and building leases. In sum, they are doing what they believe they are able to in terms of reducing expenses. There is also the legal fees for the ongoing court case. A lot of this information and more will be in the annual report. NAWS fiscal year goes from 7/1 to 6/30 and the annual report is posted on the web site approximately 6 to 9 months after the close of the fiscal year and can be viewed at www.na.org/ar . The last report is there the one from 2020.

In the past NA has relied on 70% of their operating expenses on literature sales. This is not a reality anymore and even before the pandemic it had been discussed that we must be more self-supporting as our traditions state. The goal is for member contributions be 70% of our operating expenses. We are getting there.

So although we are moving closer to our goal we have a long way to go. Our expenses in past years have been 5.5 million dollars so 70% is approximately 3.885 mil. Let's also keep in mind in 2019 we gave to the indigent and the incarcerated members over \$800,000 worth of literature and in 2020 it was over \$500,000, which is a primary way we carry the message to addict who is still suffering which is our primary purpose.

World Services is asking you to consider setting up a recurring contribution if you are able. This can be done at www.na.org/contribute.

INVEST IN OUR VISION

Most NA members are not wealthy people. In fact, many of us are just getting by. What we know about the Fellowship of NA, though, is that when we work together, we can move mountains. The simple fact of our recovery is testimony to that. "Many of us . . . sought help through medicine, religion, and psychiatry. None these methods was sufficient for us." (Basic Text, "Why Are We Here"). We are alive and recovering because of the power of our

collective efforts. Together we can do what others cannot. We need to take the same approach to funding our services. World Services is not feeling the pinch alone. Service bodies and offices around the world that have depended on profits from events or literature sales to fund their efforts are also hurting for money because of the effects of the pandemic. We can work together to fund service on every level.

Please keep in mind that World Services is still providing free literature to inmates, and areas/members that cannot afford to pay. In prior years, this has exceeded \$800,000. If the funds are not there, this service will no longer be available and this is one of the ways we carry the message to addicts who are still suffering, which is our primary purpose.

I attended the Self Support workshop: they discussed how we must be self-supporting and stand on our own. Funds, money and time must come from the members. HRP Report

Good Afternoon Florida Region,

HRP had three meetings since July 2021 Florida Region, all three were on zoom.

The first meeting took place in July with the Admin team, the following goals were identified:

Create an interview score sheet to maintain objectivity and transparency in the interview process.

Create QR code for the link to the HRP volunteer form.

Update HRP Volunteer Form, by adding a field for interested and automatic response when new forms have been received.

Automatic the communication to member before purging the forms.

Continue to update the Best practices.

HRP has begun focusing on recruitment to fill the vacant positions. Using the HRP volunteer forms, members with services experience, industry skills and clean time matching the requirement for the open position will be contacted.

HRP is down by 4 members, but only 2 positions will be filled this year and 2 next year. This is in alignment with our best practices suggests 3 HRP members will be elected in odd years and 2 members elected in even years. The clean time requirement for HRP is 8 years. In addition to looking for members with solid HR experience and service experience, we are also looking for members with strong computer skills that includes converting PDF to word as well converting word to PDF, excel spread, as well as creating and editing google docs.

In August, HRP met with the newly elected FD team to discuss expectations regarding staffing workgroups and

check-in/exits meeting with the coordinators and members of the admin team. FD team suggested when staffing workgroups in addition to including current RCM and members at large, incorporate GSR. The FD team also suggested that RCM be added to the check-in/exit meeting. HRP will start the check-in/exit meetings in October.

Also, in August HRP met with the Technology Team for training on creating QR code, duplicating the election forms, editing the volunteer forms, and creating auto-replies. It was a very productive meeting.

Currently there are 88 active Volunteer forms in the HRP volunteer form pool. An email communication will be sent in October to any member whose volunteer form is two-year-old, requesting that you complete a new volunteer

form. RSO Board Report

The Board met last Saturday via zoom. 5 of 6 members were present. We need board members. We need a secretary, and 2 more members at large. If you have an area member who was your secretary, please send them our way. We are looking for members with business experience.

Our financial position is as follows:

Total checking: \$72,289

CDs \$22,373

Accounts receivable \$ 29,153
Accounts payable \$ 13
Undeposited funds \$ 19,646

We are recovering slowly from the pandemic and our sales are climbing. we are hoping to have our sales return to the \$600,00 range. This is still down from the \$750,000 to \$800,000 range before the pandemic.

As you may know, we recovered \$50,000 from the \$104,000 theft in restitution. We have received \$24,000 from PayPal and \$10,000 from the insurance company. That leaves \$20,000 from the original theft that will be paid in restitution as part of her probation over 10 years. Eventually we will be made completely whole on this incident. Concerning the online theft of \$30,000, We have received \$10,000 from the insurance company but do not expect to recover any of the rest of the money. So, in total we have recovered \$94,000 of the total of \$134,000 and expect to receive another \$20,000 in restitution over the next 10 years.

We are still working on our QuickBooks and are bringing in our accountant, who we just hired, to finally help us get our books straight.

We are working on getting our inventory up to where it should be which is 2.5 to 3 times our monthly sales. We have a large order of around 40k on its way and will be ordering another large order for books. The WSO is out of the step working guide, so they are being back ordered. We have had to many backorders, but we hope to address them as soon as possible. Fright has been very slow and the WSO staff has been reduced. When we get it you will get it. As many of you know, Amanda has left the office and Kylie has stepped up and is doing her best to keep up. She is taking online courses about QuickBooks and is doing a good job. We are looking for another special worker and hope to fill the position soon.

I want to reiterate our need for Board members. We serve the fellowship and it is a large job. We need help! We do not have a secretary and an office manager and one other board member. We need someone who wants my job, PLEASE!

In the meantime, stop by our offices and see Kylie and Terry at 2222 South Combee Rd in beautiful downtown Lakeland in the bosom of the Florida Region.
